Terms and Conditions

- 1 By entering this promotion, you accept these Terms and Conditions.
- 2 Instructions and information on how to enter this promotion form part of these Terms and Conditions.
- The promoter is Queensland Museum (ABN 91 522 611 802) of Corner Grey and Melbourne Streets, South Brisbane, Queensland, 4101 ("**Promoter**").

Eligible entrants

- To be eligible to enter this promotion, you must be an Australian resident.
